

IN FACT, THE HOUSE EXISTS TO REDUCE THE FINANCIAL BURDEN FOR FAMILIES WHO ARE EXPERIENCING WHAT IS OFTEN A VERY COSTLY AND CHALLENGING TIME. OUR HOSPITAL PARTNER, THE UNIVERSITY OF NORTH CAROLINA HOSPITAL, TREATS PATIENTS REGARDLESS OF FINANCIAL RESOURCES. MANY GUESTS ARE FROM LOW-OR-MODERATE INCOME HOUSEHOLDS. WHILE THERE IS A REQUEST OF GUESTS TO PAY \$25 PER NIGHT, NO FAMILY IS EVER TURNED AWAY BECAUSE THEY ARE UNABLE TO PAY. OVER 60% OF THE FAMILIES SERVED CANNOT AFFORD TO COVER ANY OF THE COSTS OF THEIR STAY. THE ESTIMATE COST TO HOST A FAMILY IS

\$85 PER NIGHT. IN 2019, THE HOUSE SERVED 783 FAMILIES WHO RECEIVED MEDICAID BENEFITS FROM THE STATE OF NORTH CAROLINA. IN 2018, THE HOUSE SERVED 629 FAMILIES WHO RECEIVED MEDICAID BENEFITS FROM THE STATE OF NORTH CAROLINA.

THE HOUSE SUPPORTS FAMILIES FROM ALL WALKS OF LIFE; IN 2019, 68% WERE RECEIVING MEDICAID, AND 8.5% WERE IN THE MILITARY.
